MOTION AND ORDER OF SUBSTITUTION OF COUNSEL


C. Rauch Wise moves before the Court to be substituted as Counsel for the Appellant in the above referenced matter as he was retained by Appellant on May 10, 2021.





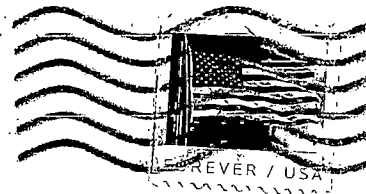
