AFFIDAVIT OF ANDREW S. RADEKER
AS TO ATTORNEYS' FEES AND COSTS

Personally appeared before me, Andrew S. Radeker, who first being duly sworn, deposes and says as follows:

1. My name is Andrew S. Radeker. I am a principal in the law firm of Harrison, Radeker & Smith, P.A. and am an attorney for the Petitioner in this case. I did the majority of the attorney work in this case.
2. My law partner Taylor M. Smith IV and our staff have spent at least a total of 145.8 hours on this case before the Court of Appeals and the Supreme Court, as the time records submitted herewith show. These records show our rates and the time spent. This matter has been pending so long that our firm has

switched billing programs during this time, which is why there are records from two such programs attached.

3. The six factors South Carolina courts traditionally consider in determining the amount of attorney's fees to be awarded are (1) the nature, extent, and difficulty of the legal services rendered; (2) the time and labor necessarily devoted to the case; (3) the professional standing of counsel; (4) the contingency of compensation; (5) the fee customarily charged in the locality for similar legal services; and (6) the beneficial results obtained. E.g., *Baron Data Systems, Inc. v. Loter*, 297 S.C. 382, 383, 377 S.E.2d 296 (1989).
4. These factors, as applied in this case, are as follows:
 - a. Nature, Extent, and Difficulty of the Legal Services Rendered. This matter was a highly contested case that required quite a lot of work and time. Working to have a court undo the errors created by the circuit court's decision – work opposed by the Respondent at every turn – took us through two levels of appellate review, resulting in briefing and oral argument on five questions that were brought before this Court on a writ of certiorari.
 - b. Time and Labor Necessarily Devoted to the Case. As discussed above, we spent significant time before the appellate courts on this case. That work was necessary for us to safeguard our client's interests meaningfully. The time and labor devoted to this case were necessary to properly protect our client's interests.

- c. Professional Standing of Counsel.
- i. Andrew S. Radeker. I practice with the law firm of Harrison, Radeker & Smith, P.A., where I concentrate my practice in civil litigation, with a particular emphasis on foreclosure cases, false arrest cases, constitutional/civil rights and free speech cases, South Carolina Freedom of Information Act cases, appeals, and consumer and lending litigation (representing debtors as well as creditors), as well as real estate litigation such as quiet title and partition actions. My work has also included representing clients in criminal defense matters, defamation (slander and libel) cases, wrongful death and personal injury cases, mechanic's lien actions, fraud and misrepresentation cases, and landlord-tenant cases. I have been a presenter at continuing legal education seminars, including the Master-in-Equity Bench/Bar CLE. I was admitted to the South Carolina Bar on November 14, 2005. I am a past real estate section chair of the South Carolina Association for Justice, have served on the Consumer Law Section council of the South Carolina Bar, and am one of the co-authors of the third edition of the South Carolina Foreclosure Law Manual. After graduating from law school, I became an associate with what was then the firm of James C. Harrison, Jr., P.A. (which since changed

its name to Harrison & Radeker, P.A. and now to Harrison, Radeker & Smith, P.A.). I have been a shareholder in the firm since 2009.

- ii. Taylor M. Smith IV. My law partner Taylor M. Smith IV is a licensed member of the Bar of the State of South Carolina, to which he was admitted on May 19, 2014. He practices with the law firm of Harrison, Radeker & Smith, P.A., where he concentrates his practice in civil litigation, with a particular emphasis on South Carolina Freedom of Information Act cases, constitutional/civil rights and free speech cases, appeals, and consumer and lending litigation (representing debtors as well as creditors), as well as real estate litigation such as quiet title and partition actions. His work has also included representing clients in criminal defense matters, defamation (slander and libel) cases, freedom of speech cases, appeals, and landlord-tenant cases. He has been a presenter at continuing legal education seminars, including the South Carolina Bar Convention. He is the lead attorney for the South Carolina Press Association, which serves more than 95 percent of the state's newspapers. He is the author of several open government guides for the Reporters Committee for the Freedom of Press. After graduating from law school, he became an associate with

what was then our firm and was made a shareholder in the firm in 2018.


- d. Contingency of Compensation. While we have this case on an hourly basis, our client is not independently wealthy, and whether attorneys' fees are awarded in this case may have a significant bearing on whether my firm is fully compensated for the work we have done on the case.
- e. Customary Fee Charged on the Locality for Similar Services. The hourly rate given above is normal and customary for attorneys' services in the Columbia area for cases that have gone through extensive briefing at two levels of appellate review. I am aware from discussions with clients, other attorneys in the Midlands region of South Carolina, and from my general familiarity with the legal profession that the fees charged for services similar to those in this case are in line with those incurred in the instant case. Accordingly, the fees for our work in this case are in line with those customarily charged in this locality for similar services.
- f. Beneficial Results Obtained. Our work has resulted in a reversal of a decision that has negatively affected our client and also resulted in a decision of this Court that went a long way in bringing this state's case law about the Freedom of Information Act back into a logical place within the precedent of this Court's decisions.
