This matter comes before the court for indigent litigant (Appellant) to proceed in forma pauperis for concerns of a fundamental right to appeal a Department or agency's final decision in South Carolina under Rule 72 SCACR, § 14-3-330, § 1-23-610 (B), (A), (C), (F), and incarcerated litigant, that cannot afford fees.

Under SCACR Rule 203 (d) (2) (B) (iii) "a filing fee as set by order of the Supreme Court, this fee is not required for criminal appeals, or appeals by the State of South Carolina or its departments or agencies."

This appeal is taken from final decisions by SCPPPS and ALC and appellant should be granted to proceed with out payment for filing fees to receive judicial review from his final order, on questions of denial of constitutional rights under the 14<sup>th</sup> Amendment.

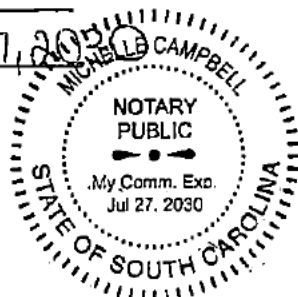
