**Motion for Extension of Time to  
File Reply to State’s Return to Cross-Petition for Writ of *Certiorari***

---

In this capital case, Jerry Inmon<sup>1</sup> moves this Court for an order extending the time to file his reply to the State’s return to his cross-petition for a writ of certiorari until Monday, June 7, 2021. This is the third request for an extension to file this pleading.

This request is not intended for delay. Ms. Holt continues struggling with grief from the loss of her eldest child. Mr. Grose prepared for the jury trial in *State v. Travis Miller*, Indictment Numbers 2019-GS-30-01274 and 01275, an attempted murder case, which was scheduled for the May 24, 2021 Term of General Sessions Court. Although the case was not reached, substantial preparation time was required. Additionally, he filed the Record on Appeal and Final Briefs in the Court of Appeals in *State v. Shawn Custer*, Appellate
