**MOTION FOR EXTENSION OF TIME
TO FILE RESPONDENTS' RETURN
TO APPELLANT'S PETITION FOR REHEARING**

The above-named Respondents, the Darlington County School District and the South Carolina School Boards Insurance Trust, respectfully request that the Court of Appeals grant an extension of time to file their Return to the Appellant's Petition for Rehearing.
