Mary,

Since this Court's letter dated today requires a bound, printed copy of the Record on Appeal, I would point out a couple things:

The Record on Appeal Mr. Hutson filed on May 26, 2021 is substantively deficient in at least two respects. First, it does not appear (as of my last check yesterday) that Volume 2 was filed. Second, one document in Volume 3 was incorrect. Specifically, pages 929 to 960 are supposed to be a complete copy of my Bates-labeled Exhibit V. That portion was correct in the February 22, 2021 version, but for some reason is a hodgepodge in the May 26, 2021 version.

A motion to this effect is forthcoming. However, this e-mail represents a good-faith attempt to resolve this issue without a motion. If Mr. Hutson files Volume 2 and re-files Volume 3 with the correction, our need for a motion on that issue would be moot. This e-mail seeks to save this Court and Mr. Hutson the time and expense of yet another improper filing of the Record on Appeal and additional motions practice.

Also, please remove Sharon Hughes from the distribution list and add Lauren Hubbard as my legal assistant.
