At a Court of General Sessions, convened on JANUARY 3, 2019 the Grand Jurors of FLORENCE County present upon their oath:

**COUNT ONE- MURDER**  
CDR: 0116 16-03-0010,0020

That DONALD DAYQUAN SMITH did in Florence County, on or about August 3, 2018, willfully, feloniously, and intentionally kill the victim, Qatar Ramadan, with malice aforethought, either express or implied, by means of blunt forced trauma, and the victim did die as a proximate result thereof on or about August 3, 2018 in Florence County, in violation of Section 16-03-0010, S. C. Code of Laws, 1976, as amended.

**COUNT TWO- CRIMINAL CONSPIRACY**  
CDR: 0049 16-17-0410

That DONALD DAYQUAN SMITH did in Florence County on or about August 3, 2018 combine with Aliyah Azhane Hill, and/or with other persons, for the purpose of accomplishing a criminal or unlawful object or an object that is neither criminal nor unlawful through criminal or unlawful means, to wit: Murder, in violation of Section 16-17-410, S. C. Code of Laws, 1976, as amended.


