

WHEREFORE, the Appellants respectfully request this Honorable Court grant their Motion and issue an Order relieving the undersigned as Counsel for the Appellants.





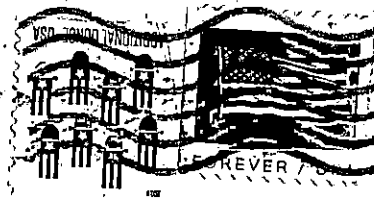
