I, Kelvin Wayne Crosby am a Legal beneficiary of the estate of Annie Mae Crosby, my deceased mother.


Please correct legally as your own documents noted a Deficiency of Appeal mistake that do not allow me any recourse in the future of events that may happen in this matter.

Please correct this legal deficiency...



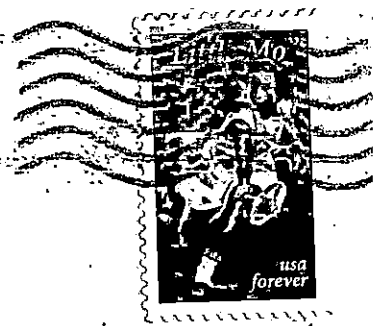
