We represent Wells Fargo Bank in the above-captioned appeal. On June 2, 2021, this Court gave Ms. Hodges until June 7, 2021, to cure deficiencies outlined in the Court's May 5, 2021, order regarding the filing of her "proposed amended initial brief." On June 3, 2021, this Court granted Ms. Hodges' motion to supplement the record on appeal.

The purpose of this letter is to notify the Court that, pursuant to Rule 211(b), SCACR, Wells Fargo opposes any changes to Ms. Hodges Initial Brief. *See* Rule 211, SCACR (the final brief shall be identical to prior brief and served within twenty days after service of the Record on Appeal). Furthermore, the 10 days required by Rule 208, SCACR, to file or serve a reply brief has expired.
