
**RETURN TO RESPONDENTS'  
RETURN TO MOTION TO REINSTATE APPEAL**

It is plenty obvious that it is Mr. Duncan who has drafted the Respondents' Return to Motion to Reinstate Appeal proving that Mr. Duncan's apparent withdrawal was merely a ploy to get the Appeal dismissed over timely proof of service. For Mr. Duncan never addresses the key issues, and the objection follows this same pattern in which there is not one word devoted to why the Respondents failed to accept the Certified Mail (Exhibit No. 2) for which a certificate of service and Certified Mail receipts were submitted to the Court with the initial filing. Their failure to accept mail created a doubt over their present address, an inquiry to which Mr. Duncan did not respond (Exhibit No. 4).

As the Appellant will demonstrate in his brief to come that even the defense presented by Mr. Duncan in the lower court amounted to nothing short of a fraud in its own right. As to the transcripts of the hearing, they are not necessary in cases of summary judgment, and hardly anything was said on either side in the barely three (3) minute Zoom hearing due to audio problems, and a request for a rehearing was denied by Judge Maddox who was obviously biased in favor of Mr. Duncan, seems to not have read any of the filings and ruled contrary to the evidence presented in the case. The Appellant again asks the Court to kindly reinstate this matter.

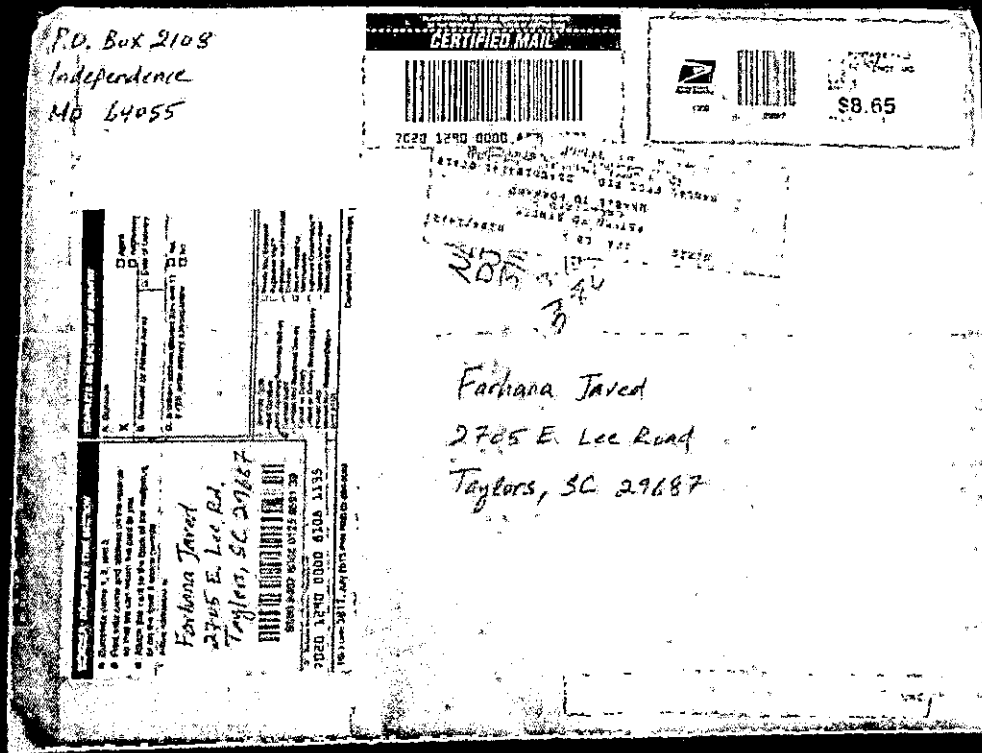
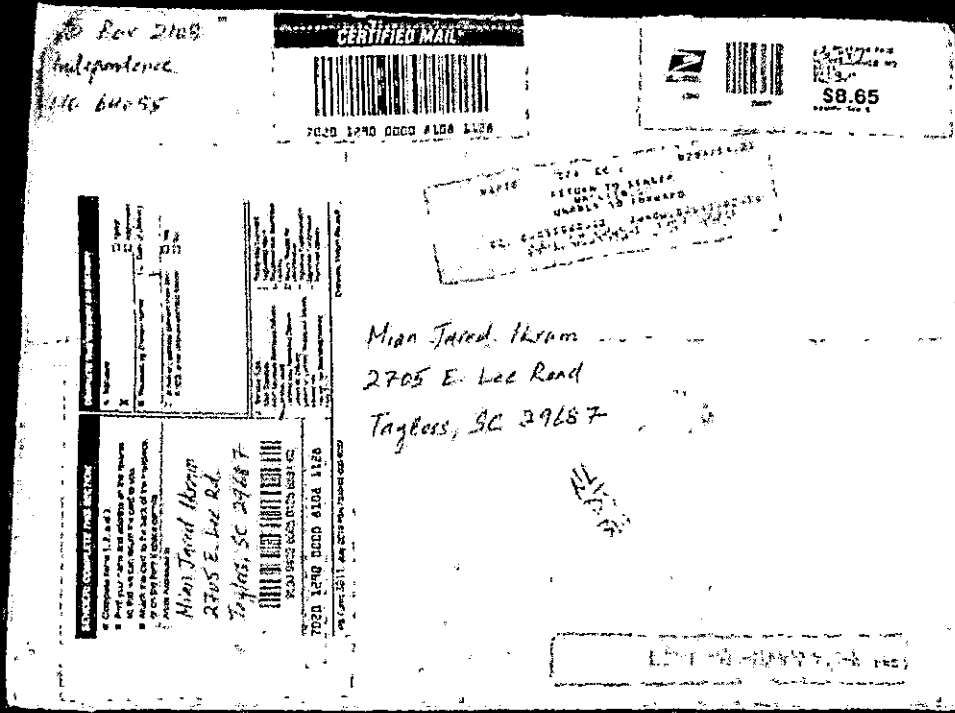
