ORDER

First, Respondent's motion to dismiss is denied. Second, Respondent's motion to file a belated return to the petition for writ of certiorari is granted. Furthermore, Respondent's request to require Petitioner to supplement the appendix with the transcript from Judge Griffith's October 21, 2020 hearing is granted. Petitioner's request to proceed with a review of this case without the transcript of the October 21, 2020 hearing is denied.

Within thirty days of the date of this order, Petitioner shall provide proof he has ordered a copy of the October 21, 2020 hearing transcript.
