Respondent's attorney Imani Diane Byas did not comply within 10 days of the Court of Appeals letter dated May 28th, 2021, ordering Counsel (Respondent) to send the Court (1) bound copy of the record on appeal and all final briefs. Nor did Respondent file for an extension for more time to comply with the Courts order.

Due to the above facts appellant is motioning the court to dismiss Respondent's case, and therefore grant appellant's case, by granting him the relief that he is entitled to. Law and SCOC policy's declare appellant a "No-Parole" offender should receive. (See Appellant's Argument in his brief pg 2-9).



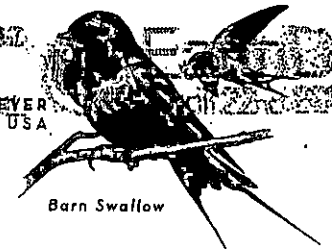
