THAT HE IS IN A MENTAL HEALTH UNIT AND IS ON
MEDICATION AND HAS REQUESTED FOR ADDITIONAL HELP
IN THE FORM OF LEGAL ASSISTANCE FROM THE COURT AND
WAS DENIED.

I AS Jail House lawyer HAS WENT OVER
PETITIONERS ISSUES AND EXPLAINED TO HIM BEST AS I
COULD POSSIBLY DO AND HE HAS DECIDED TO ASK
THIS COURT TO GRANT COMPETENCY EVALUATION.

HE HAS BEEN THRU ALL THE LOWER COURTS HAVING
HIS ISSUES DENIED AND HAS EVEN REDUCED A FEW
ISSUES TO SATISFY THE COURTS AND THE FEDERAL COURTS
SENT BACK TO LOWER COURTS BECAUSE THINGS NEEDED
TO BE JUSTIFIED AND NOTHING HAS BUT JUNE WHITE

PETITIONER REQUESTED EVALUATION AND WAS DENIED WITHIN MOMENTS OF HIS REQUEST BY JUDGE KING. DIDN'T EVEN ASK FOR A RECESS TO DISCUSS IT WITH PETITIONER'S ATTORNEY. (SEE TRANSCRIPTS)

PETITIONER ASKED HIS ATTORNEY TO BEG THE JUDGE TO UNDERSTAND THAT HE WAS NOT STABLE AND CURRENTLY ON MENTAL HEALTH NARCOTICS.

PETITIONER HAS BEEN LIVING IN MENTAL HEALTH UNIT FOR OVER 12 YEARS. TAKES MEDICATION (2) TIMES PER DAY AND (3) DIFFERENT KINDS. HE IS PRAYING THAT THIS COURT GIVES HIM THE JUSTICE HE DESERVES.

THIS IS AS WELL AS OTHERS HAS BEEN OVERLOOKED FOR (15) YEARS AND ~~ITS~~ TIME FOR PETITIONER TO HAVE A FAIR BITE AT THE APPLE.
