The Court of Appeals has ruled that the order on bifurcation is not immediately appealable. I understand from the rule that the Remittitur will be sent in 15 days. If USF&G does not intend to go forward with any additional motions in the appellate court, I believe the remittitur could be sent earlier by order of the Court of Appeals. It would be helpful to know about USF&G's plan.
