Dear Ms. Kitchings:

I am in receipt of a letter dated June 15, 2021, from your office requesting the status of the transcript in this case. I believe that the "transcript overdue letter" was sent in error because there has been no transcript ordered for this appeal.

By way of explanation, the Notice of Appeal was filed on May 12, 2021. There is no transcript needed for this appeal, and none has been ordered. As a result, the Appellant's Initial Brief was due on June 11, 2021. On that date, the Appellant filed a request for a 30-day extension for the filing of its Initial Brief. In looking at the Court's docket for Appellate Case Number 2021-000501, the extension request letter filed June 11, 2021 does not appear. However, I did receive a filed copy of that extension letter back from the Court, and I attach a copy for your records. That extension request has not yet been acted upon even though it was the first extension request made with respect to this appeal. With the requested extension, the Appellant's Initial Brief will not be due until July 12, 2021.

Therefore, I would ask the Court to include the filed extension request letter (copy attached) in the Court's docket and to grant the requested extension. There is, however, no transcript that has been ordered for this appeal.
