

Dear Ms. Allen,

I am writing in response to your letter of June 14th requesting an update on the transcripts. There are actually two transcripts in this matter, the first involving a short hearing before Judge Buckner, and the second concerning the hearing on the merits before Erin Dean, Special Referee. (Judge Buckner decided *sua sponte* to send the case to a Special Referee.) I have ordered both transcripts, and both court reporters inform me that I will receive each transcript this week. The main transcript was the hearing held remotely before Erin Dean as special referee, and her office made arrangements with Clark & Associates to cover the hearing. Because Ms. Dean handled the hearing remotely, and because the court reporter was with Ms. Dean in Beaufort, I do not know his or her name. However, I have a job number, and when I checked with Clark & Associates this morning (June 16th), the "production department" informs me the transcript is prepared and will be mailed out to me this week. Likewise, the court reporter who handled the appearance before Judge Buckner, Mona Manley, likewise informs me the transcript is ready and will be mailed out this week. (I prepaid for the transcript prepared by Ms. Manley; Clarke & Associates has not billed me yet for its work.) Since I expect both transcripts this week, I decided not to file for an extension because I anticipate I will have both before the Court could act on a request for extension.
