This is SC Court of Appeals  
I am writing in regards to  
my appeal. On April 20, 2020,  
Warrant # 202019462030105  
I went to jail in Rock Hill  
City in York County S.C. While  
I was in jail my probation  
officer Agent. Carr put a  
warrant on me too. I went  
to jail for possession of  
crack 3rd the city gave me  
a PR bond and sent me to  
the county for Probation, on  
a 50,000 bond, I sat in the  
county for 144 days. When I  
went to court my lawyer  
told me I couldn't have my  
days, but I had to plea  
guilty to the possession charge  
that got me the violation. I  
don't understand why I couldn't  
get 144 days for this. I didn't

ask the county to PR me  
and I didn't get to go home  
because they PR me. I would  
like to have my 144 days  
second. The whole time  
Mrs. Pesequese was telling  
me that I had to plea  
to all my charges when I  
went into the courtroom.  
She never informed me that  
the solicitor dropped all but  
4 charges until right before  
we went into the court  
room. That's when she said  
I had to plea to couple of  
them and then she didn't  
even know which one's  
they were. The whole time  
I wanted to do a open  
plea but she keep talking  
me out of it, she said  
she believed I would have

gotten more time, I don't think I would have. I have been trying to get into a rehab and she wouldn't even help me with that, so, I did it myself. I had ~~2~~ rehabs that would have accepted me the were e-mailing me while I was in the county she said that Mrs. Peseque would never return her calls, and the other I talked to and she accepted me. I told my lawyer that, I wanted to go in front of the judge with an open plea. My recommendation from Probation was 6 mos at SCDC and Add 3 years to my probation. I wanted to go in front of the judge with my acceptance

letter from the rehab and the recommendation from probation in asking the judge to run my charges current but my lawyer said the judge wouldn't give me rehab and him might would have give me more than 5 years. If I would have known that I only had to plea to 4 charges I would have went in there with an open plea. But she had me thinking that I had to plea to all these. She told me before that she didn't feel that rehab would do me any good. At one time she said she didn't care what I choice to do in the courtroom

because she gets to go home everyday, I don't feel as she wanted to fight for me. I feel as hell and my solicitor were working together because she did not defend me at all. I have been fighting with a drug addiction for a while I got accepted into a long term rehab and she wouldn't even try to help me get in there through the courts. She really didn't talk for me either. I feel she didn't fight hard enough to get me my 144 days. I sat in the court. I should have gotten 216 days credit and I only got 122 days credit that's a big

difference. I think she is rude and very unprofessional and she doesn't care about the well being of her clients. I don't want her representing me on this appeal. I feel as if I had a different Public Defender I would have gotten a better plea.

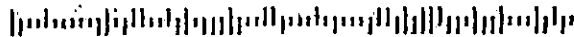
