


- (1) I am the applicant in this action and I believe I am entitled to redress.

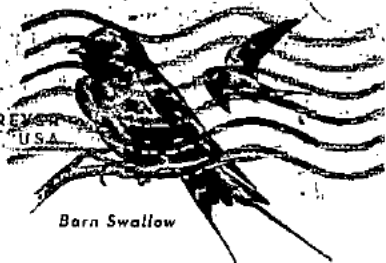
