1. On February 8, 2021 Judge Steven Johns mailed to Defendant a letter notifying the Defendant of his intent to appoint the Defendant counsel from the Public Defender's Office unless he heard from the Defendant within (10) Ten days of date on the letter.

2. On March 2, 2021 the Defendant received the letter at Kershaw Correctional Institution. (See Exhibit A).

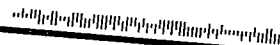
