





did within this county and state on or about 8/18/2016 violate the criminal laws of the

State of South Carolina (or ordinance of County/ Municipality of Myrtle Beach)

in the following particulars:

DESCRIPTION OF OFFENSE: Burglary / Burglary (Non-Violent) - Second degree

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On August 18, 2016 Officers responded to a Burglary call at the Barrel Bar and Grill located at 2303 S. Kings Hwy. within Myrtle Beach. At approx. 04:54 hours (night time) Officers met with the owner of the business after the alarm was activated and it was learned that the business was broken into and a bottle of liquor and keys were stolen. Video surveillance at the business captured the image of the burglar at the time of the theft and a green handled knife with the words "Zombie Killer" was left behind by the Suspect. On 8/27/2016 the Defendant was identified as the person seen in the video surveillance burlarizing the business and placed under arrest.
