Gibbons, the Appellant pled guilty to Two Counts of Assault & Battery 1st Degree and Resisting Arrest (Indictment Nos.: 2019-GS-46-06807; 2019-GS-46-06808 and 2021-GS-46-02549) and received a deferred sentence. On June 24, 2021 in front of the Honorable Daniel D. Hall, the Appellant received a sentence on ten (10) years on the Two Counts of Assault & Battery 1st Degree (Indictment Nos. 2019-GS-46-06807 and 2019-GS-46-06808); and time served sentence on the Resisting Arrest (Indictment No. 2021-GS-46-02549). Also the Appellant pled guilty to Resisting Arrest with a Deadly Weapon (Indictment No. 2021-GS-46-03472) and was sentenced to a five (5) years by the Honorable Daniel D. Hall. The Appellant also received credit for time served and the sentences to run concurrent.



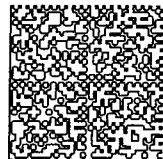
