**COUNT I: TRAFFICKING METHAMPHETAMINE**

That STEVEN MICHAEL JORDAN did in Greenville County, on or about the 23rd day of August, 2019, knowingly sell, manufacture, deliver or bring into the State of South Carolina or did knowingly provide financial assistance or otherwise aid, abet, attempt or conspire to sell, manufacture, deliver or bring into the State or was knowingly in actual or constructive possession of 200 grams or more but less than 400 grams of Methamphetamine (Crank). This is in violation of §44-53-0375 of the South Carolina Code of Laws (1976) as amended.

**COUNT II: POSSESSION OF A WEAPON DURING THE COMMISSION OF A VIOLENT CRIME**

That STEVEN MICHAEL JORDAN did in Greenville County, on or about 23rd day of August, 2019, possess or visibly display a HANDGUN during the commission or attempted commission of a violent crime, to wit: TRAFFICKING METHAMPHETAMINE. This is in violation of § 16-23-0490 of the South Carolina Code of Laws (1976) as amended.
