MOTION TO EXTEND ABEYANCE

Pursuant to Rule 240, SCACR, Appellant Carolina Custom Converting, LLC (“CCC”),
with the consent of Respondent David Wilson (“Mr. Wilson”), hereby moves the Court to extend

the suspension of the appeal for an additional 15 days up to July 15, 2021, or until receipt of the forthcoming notices of appeal from the underlying orders issued in the below litigation, whichever comes first. After filing the notice of appeal, CCC moved the Court to hold the same in abeyance until the lower court issued further orders resolving the remaining issues in the case. On December 29, 2020, the Court granted the motion to suspend the appeal. On March 12, 2021, this Court issued an order further extending the abeyance. Subsequently, the lower court oversaw briefing and argument on the remaining issues and subsequently entered orders. On June 17, 2021, the lower court denied the Rule 59(e), SCRCP, motion. Consequently, the notices of appeal from the other issues decided in the lower court will be served and filed in the near future. As a result, CCC, with the consent of Mr. Wilson, seeks an order extending the abeyance of this appeal for 15 days up to July 15, 2021 or until the service of the notices of appeal from the recently entered orders, whichever occurs first.
