



RULE 203(B) EXPLANATION

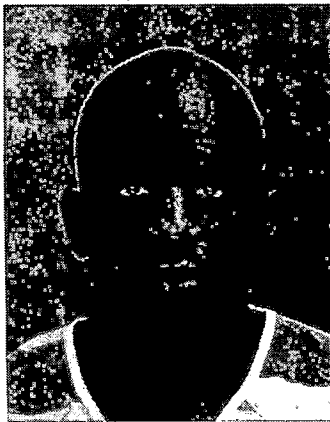

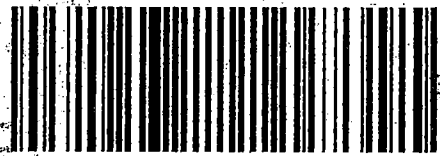
