
Dear Hon. Kitchings

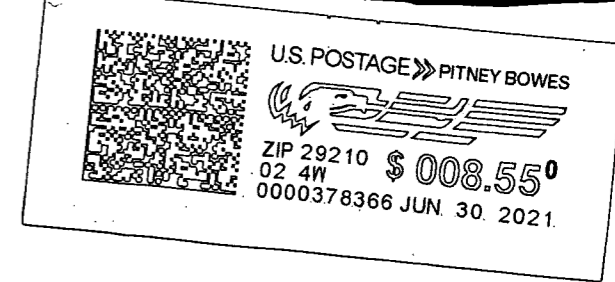
