NATURE OF OBJECTIONS

1. Motion was titled: “Motion Requesting Restoration of the Original Case Title”.
2. The original case title was defined as text from the original caption that was changed due to clerical error.
3. Motion made the original case caption a matter of record with this Court.
3. Motion asked for correction of a clerical error.
4. Motion asked for **restoration** of the original case caption.
5. Motion did not ask to “... **amend** the caption ...”, different from the original case caption.
6. Order misstated (emphasis added): “Appellant’s motion to **amend** the caption is denied”.
7. Misstatement in Order is an **Error of Fact**.
8. Order mistakenly denied a motion that was **not** filed by Appellant.
