The above Transcript is from the Court of Common Pleas proceeding which took place on September 8, 2020.



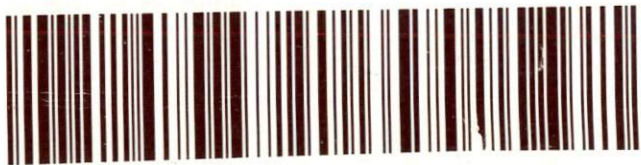
