MOTION AND ORDER OF SUBSTITUTION OF COUNSEL


C. Rauch Wise moves before the Court to substitute Counsel for the Appellant in place of Andrew J. Johnston in the above referenced matter.





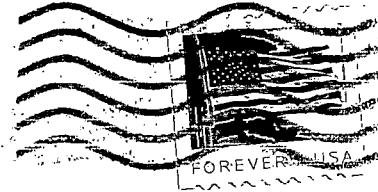
