NOTICE OF APPEAL

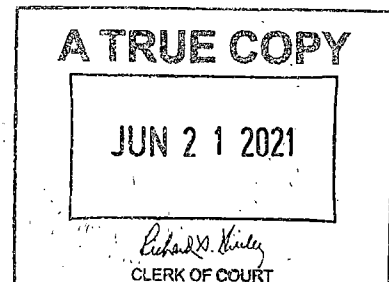
