The underlying matter ended up in the US District Court for South Carolina, Case Number 2:19-cv-2593-RMG, where we successfully mediated a resolution on May 12, 2020. While the jurisdictional questions posed in our appeal were not resolved, a resolution was able to be achieved without those questions being answered. In addition, since our resolution did not address the jurisdiction issues of our appeal, I did not think we needed the Appeals Court to approve the Agreement.

I do not believe the appeal needs to proceed so long as Mr. Mack is in agreement.
