But the last time Me and Mark talked was
at my Bond Hearing and received a 5000\$
Bond on each of my charges, I made Bond
and received a letter from Mark that told
me we would not have court for the foreseeable
future because of covid. But when I seen
him on April 28 He told me this was
the first my case has came across His Desk
since my Bond Hearing and He wasn't familiar with
the facts in my case so He lied about the do
trying to scare me into taking the 0-10
year pe. I also advised Mark that I made
Bond that very same day but had to

Serve 20 Days Contempt. And I Begged My
lawyer Mark to push it out But He told
me that all we could was fight the Bond
revocation. And I ask Him how long before
I got a Bond again. And He told me
I wouldn't get another Bond. And I ask Him
about trial and was told I couldn't win trial
Based on the fact that my victim was more
likable than me. And I told my lawyer it
wasn't fair for court to make me try and
sign a plea just because my case was back
logged because of covid 19. And the court
wanted get rid of the old cases. And I was
told that we had court the following day
on April 29th 2021, Thursday. But Thursday
I sat in a court room holding cell from
8:30 am till 4pm without going to court.
The following day Friday April 30th 2021 I went
to court, before my lawyer came to see

He told me He told me That He couldn't
win My Bond and they would take it But
said that I could sign the pe for 0-10
And He could talk the court into Not touching
My Bond and Deffer the sentencing So I
could go Home For Two Weeks to Be with
My wife and Kids. And told me If I Didn't
take that pe that they could take My Bond
And we could go to court Within 6 months
of me Being In Jail And lose at trial and
I could get more than ten years and couldn't
Be able to see My Family For two week
Before I go to serve My time So From
right then My thoughts of running where on
My mind And not only that When My
lawyer told me about what we would
go

In Front of the Judge I was to ³ Say No.
When asked if anyone touched or made
a Deal with me, keep in mind I've never
Signed the Ple with my name and we only
went in front of the Judge to get Him to
accept the Ple ten Days later I was let
out of Jail I was out for two weeks
Before I went on the run, I ran for a
week before I was locked up again.
While I was out I asked my lawyer
if we could file to withdraw my Ple
and was told No Nbl that we put in
for it and the Judge said No But Just
No even after I asked.

I asked on the fact that I learned you
can withdraw your plea if there is a
chance of trial but my lawyer told me no.
I even called his boss Bryson J. Barroccio
and he wouldn't talk to me talked to
Deputy Public Defender Melissa A. Inzerillo
and all she told me was that the judge
probably wouldn't go for that but not once
asked or put in to do it after I was
caught and about to get sentenced I told
my lawyer I wasn't going in to sign.
He told me that the DA said I could
get a box car ten for resisting arrest instead
of concurrent sentences so I'm asking
in this letter that it be reviewed

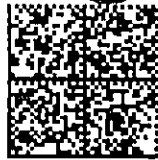
