Dear Madam Clerk:

Please accept this as a periodic status report for the above-referenced case. This appeal was filed by my client, Ms. Martin, from the final order of the Richland County Master-in-Equity in 2017. Subsequently, the Court of Appeals held the case in abeyance while a Rule 60 motion was heard by the trial court. Ms. Martin's motion for new trial was granted and a second appeal (2019-000569) was then filed by Country Properties, LLC. Ms. Martin filed a new motion to stay the above-referenced first appeal while the second appeal was resolved. The Court granted the motion to hold this appeal in abeyance on July 22, 2019 and this 90-day status report conforms with that order.

Final briefing was completed in the second appeal in August 2019. Oral arguments in the second appeal were heard February 10, 2021. Thus, the second appeal is now pending a decision. Because a dispositive order has not yet been entered in the second appeal, this appeal should remain in abeyance for now. Please let me know if you have any questions or concerns.
