I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

Affiant, an investigator with the Greenville County SO, is investigating the death of the victim. An autopsy performed on the victim shows that she died as a result of wounds caused by a cutting instrument. Affiant also has documentation that shows that a short time after the murder the defendant went to An Med hospital for treatment regarding two cuts to his left hand. The defendant is an ex-boyfriend to the victim who has been attempting to cut off all contact with the defendant. Affiant has a statement from a witness in which she states that the defendant borrowed her vehicle on the night of the murder. This witness states that the defendant came back with the vehicle which had blood in it and he had blood on him as well. Affiant has cell phone tower records that show that at approximately 8:35 PM his cell phone utilized a cell tower less than a mile from the incident location. The defendant did kill the victim with malice aforethought. This incident occurred within Greenville County, SC.

Deputies say the man wanted for stabbing a woman to death earlier this month has been arrested.

Sylvester King, 45, is charged with murder and weapon possession in connection with the stabbing death of Janice Hackett-Lewers, 42.

The United States Marshals Task Force and Greenville County deputies arrested King in Spartanburg County, Wednesday night.

Deputies found a woman dead in her home after she called 911, according to Greenville County Deputies.
