Madam Clerk:

I am writing in regards to the above-referenced appeal, which is docketed under case number 2020-001406. This appeal concerns in part an award of attorney's fees to my clients, Mr. and Mrs. Golson. The lower court relied in part upon a statement of our fees that was submitted *in camera* to avoid breaking attorney-client privilege or work product privilege by disclosing the fee entries to opposing parties.

Naturally, because Appellants do not have and cannot see a copy, the fee report is not in the Record on Appeal (although it was designated). We have scoured the appellate court rules and have found no reference as to how to handle the filing of *in camera* exhibits from the lower court. We are wary of sending in the document without a procedure in place, since under such circumstances the document may be placed on C-track. As I understand the procedures, a motion to seal would not be sufficient, as sealed exhibits are disclosed other parties (albeit not to the public).
