
Dear Madam Clerk,

I would like to register my objection to Appellant's request for an extension which she bases on the grounds that she never received Respondent's Initial Brief. First, the Respondent's Initial Brief has nothing to do with her production of the Record on Appeal. She makes no claim that she never received Respondent's Designation of Matters to Include, which would directly affect her ability to create the Record on Appeal. 
