**SUGGESTION OF BANKRUPTCY OF
DEFENDANT AND NOTICE OF STAY**

PLEASE TAKE NOTICE that on October 7, 2020, Ruby Tuesday, Inc. (the “Debtor”), a
Defendant in the above-captioned proceeding, and certain of the Debtor’s affiliates (collectively
with the Debtor, the “Debtors”) each filed a voluntary petition for relief under chapter 11 of title
11 of the United States Code (the “Bankruptcy Code”) commencing the jointly administered
chapter 11 bankruptcy case styled as: *In re RTI Holding Company, LLC*, Case No. 20-12456 (JTD)
in the United States Bankruptcy Court for the District of Delaware (the “Bankruptcy Court”). A
copy of the Notice of Commencement is attached hereto as **Exhibit A**. Pursuant to the automatic

stay imposed pursuant to section § 362(a) of the Bankruptcy Code, all claims, causes of action and proceedings commenced against the Debtors or the Debtors' property are stayed.

PLEASE TAKE FURTHER NOTICE that on February 17, 2021 the Bankruptcy Court entered the *Findings of Fact, Conclusions of Law, and Order Confirming the Debtors' Second Amended Chapter 11 Plan, as Modified* [D.I. 1144] (the "Confirmation Order") approving the *Debtors' Second Amended Chapter 11 Plan, as Modified* [D.I. 1093] (as amended, the "Plan"), which became effective on February 24, 2021.

PLEASE TAKE FURTHER NOTICE, the Plan and Confirmation Order provide for the discharge and release of claims against the Debtors pursuant to sections 524(a) and 1141(d) of the Bankruptcy Code as well as the permanent injunction of certain actions, including the commencement or continuation in any manner of any action or other proceeding of any kind on account of or in connection with a discharged and released claim.
