

MOTION TO SUPPLEMENT RECORD ON APPEAL

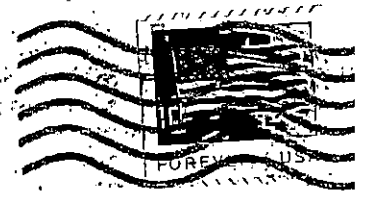
