To the Court,

This e-mail is responsive to Mr. Hutson's letter to the Court dated July 23, 2021 as his proposed changes involve material I designated for the ROA. I believe Mr. Hutson's requested relief will require a filed motion.

To avoid dragging this out, I attached an e-mail that I took to be Mr. Hutson's attempt to file Volume II of the Record on Appeal back in May. I have reviewed it and find it to be consistent with Hutson's ROA filed February 22, 2021 (see attached Order of this Court filed July 15, 2021). I thought filing Volume II would be a simple matter of correcting an oversight.

As for Volume III, the Order requires Mr. Hutson to substitute approximately 30 pages that were incorrect in the May 26, 2021 version. Mr. Hutson has the documents because they were included in the February 22, 2021 version. I see no reason to re-start the process as Mr. Hutson seems to suggest in his letter. Accordingly, I intend to oppose Mr. Hutson's proposal.
