JOINT MOTION FOR EXTENSION OF TIME
TO FILE RECORD ON APPEAL AND FINAL BRIEFS

NOW COME the Appellant Exquis Event Center and the Respondent BRE Retail NP Festival Centre Owner, through their respective counsel, pursuant to Appellate Rules 210, 211, 240, 263, and hereby jointly move for an extension of time for Appellant to file the Record on Appeal and also for the parties to file their Final Briefs, for sixty (60) days, and in support thereof, state the following:

1) By Order of this Court the deadline for Appellant to file the Final Record on Appeal and for the parties to file their Final Briefs is July 28, 2021.

6) This is the second request for an extension of time of the deadlines to file the Record on Appeal and/or the Final Briefs. This motion is timely made prior to the expiration of the current deadlines.

WHEREFORE, for all of the foregoing reasons, and for good cause shown, the parties jointly request the entry of an order extending the time for Appellant to file the Record on Appeal and for the parties to file their Final Briefs for sixty (60) days, through and including September 27, 2021.
