
**MOTION FOR WITHDRAWAL AND SUBSTITUTION OF COUNSEL FOR





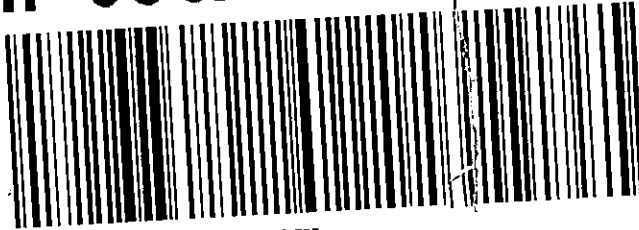
