Now even threatened to be sued by our insurance company to not cover any award giving to Kim Likins to pay back her theft and worse, use any excess tax funds to go into her pocket and the lawyers. The lawyers now are working on contingency after they were forced to stop being paid with stolen tax monies for Ms Likins private use. It's all so criminal, and it further puts me at a financial competitive disadvantage having to pay in the beginning from my pocket to defend myself against unlimited stolen public tax monies. To make it worse for my tirades on trying to expose all this corruption, I get a \$4500.00 gag fine by Judge Dukes and his buddy Alford, to go into Alford's and Kim Likins pocket, and I want this money/ theft paid back to me. To date no law enforcement, judge, Mayor, Town Council or many lawyers are acting on this or even speaking up on and seems all in fear. Therefore, I must take extreme measures with tirades to get this the attention it needs. Acting nicely does not work, I tried that 20 yrs ago.

Question for me is how do I get the best justice and result? Is this by continuing playing in this illegal SC system and keep trying to defend my credibility as a nasty tactic by the other side to win, take the spotlight off them, so they can keep stealing tax money, or tell everyone in SC to go to opposite of Heaven and let the Judges, FBI, Sled and the crooks and illegal criminal Town lawyer Gregg Alford figure it out? 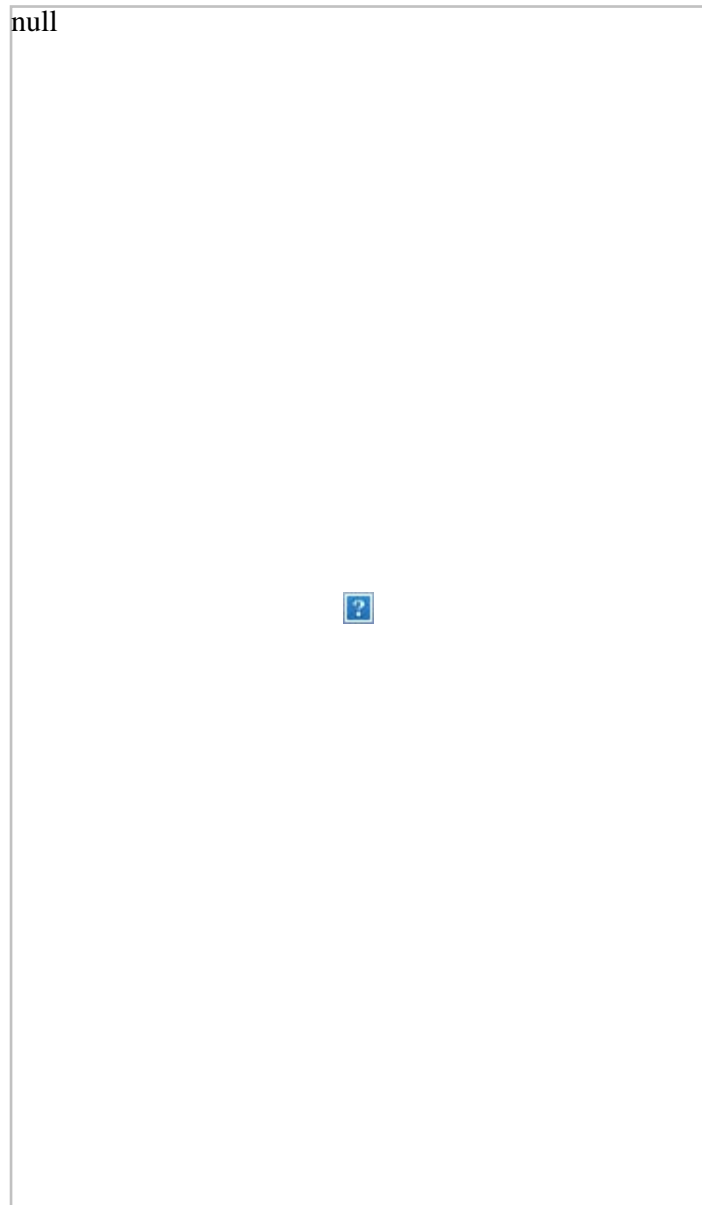
