My reason for writing is because I need advice on my situation. I am currently in my appeal which I had to go back on my PCR to receive due to ineffective assistance of counsel. I decided to write you because I know that you will uphold the law by any means. I have several issues at hand that I am fighting for. For One is lack of an informed plea in which I did not find out that my sentence was 85% until after being sentenced by Mr. William H Seals. Proof of that matter is in my transcript. Second is Prosecutorial Misconduct, third is Lack of subject Matter Jurisdiction, Forth is Perjury, and last is abuse of discretion. Oh and I'm sorry "Miscarriage of Justice." I was indicted on a Multicount indictment that is very defective on it's face and body which were errors that I were blind to the fact about due to ineffective assistance. My Charges as a total were

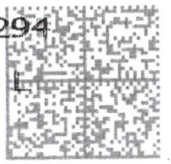

Two major issues with my indictment are that, my Burglary first degree charge on indictment states as follows: That Larry Anthony White Jr, did in Marion County on or about December 22, 2016, Willingly and unlawfully Attempt to enter the dwelling of Terrance Williams, located at 122 Belin Court, without consent and with the intent to commit a crime therein, and the defendant was armed with a deadly weapon, in violation of the Common Law and Section 16-11-311, S.C. Code of Laws, 1976, as amended. Now if I'm not mistaken "Burglary in the first degree under South Carolina Criminal Law 16-11-311 is a Felony Criminal offense characterized by the defendant unlawfully entering the residential dwelling of another person." I'm just trying to figure how could I manage to get indicted and they stated that I made an attempt? Second is instead of me getting indicted for Conspiracy to commit kidnapping which I was charged with, I was indicted for Criminal Conspiracy but the warrant number stayed the same. Which Criminal Conspiracy and Conspiracy

to Commit kidnapping cannot both have the same
