

---



Haynsworth Sinkler Boyd, P.A., successor to Sinkler & Boyd, P.A. (Haynsworth Sinkler) filed a motion to dismiss the cross-appeal filed by Cynthia Holmes. After careful consideration, the motion is granted in part. The motion is granted and Holmes's appeal of all orders except the June 10, 2020 order denying relief and the June 26, 2020 order denying the motion to reconsider are dismissed.
