I'm just an ROTC cadet that was waiting for enlistment processing that was doing decisive civil investigations into the Cannabis industry for colleges and got into deep stuff. Please forgive me, I'm scarred for life. I'm sorry for being Unorthodox, I'm not from South Carolina and I don't know how to defend myself besides being completely honest. I was told by an officer to write you guys and pray so I am. My love and prayers be with you, thanks. In Jesus name I do pray.

I write this letter unlike others, with heart mind and heed in one. My heart lies with Randy, (and with you guys as well) and I want you all and our friends and connects to know that; I was stuck in a breaking point position where I lost my being and succumbed the worst death of all, hurting someone I love to the point of no return. I had people threatening me and Randy following it up with double sided antagonism. Then he scared me with his threat to do something to no one else could do. Facebook contains all of the threats which Lancaster county sheriffs office has record of, of the messages between Dave Antonio Sousa and Randy Tran from November 2015 - April 2016. November containing the threats which forced me to come to South Carolina to make cannabis sales to pay back Randy Tran and my friend Greer Menose. Threats from proff. Greer Menose ~~to~~ Dave Antonio Sousa are recorded from July 2015 - April 2016. Also Records from Oregon State Hospital show that reports of threats to my family were reported to Oregon State Hospital by my stepmother Kimberly Ann Kucinski, <sup>slashed</sup> car tires and broken windows on the house of my father were the extent of the damages. On April 5th 2016 I was coerced to a make a sale or die decision, my response was to shoot Randy Tran, take the car and merchandise and pay Greer Menose back and tell home anything. Two days later I turned myself in after being seen trying to put Randy Tran into a trunk. It was a heart breaking choice that damaged my soul even to this date. I suffered a drug induce psychosis due to being spited by these individuals, in Oregon and I will never...

I don't want any problems with anyone. My family makes goat cheese so I wouldn't be going anywhere but to the field to make goat cheese or to my grandpa to sit and eat with them. I miss their greatness. Please please dismiss my case and allow me self-transport to the Azores. I promise you'll have no issues out of me. If there's anything else I need to show you all I'm here and am willing to work with everyone because I'm safe and Jesus is with me. Please forgive me, I was only protecting myself and my family from angry drug dealers. I'll never touch a drug in my life again except my medicine.
