**THIS MATTER** came before the Court for a jury trial on claims and counterclaims for legal damages, which was conducted July 26-28, 2021. Plaintiff Julia Sibley-Jones, in her capacity as Personal Representative of the Estate of William A.L. Sibley, Jr. ("Plaintiff"), also sought an order and judgment directing delivery of certain funds, specifically \$440,000.00 plus accrued interest, being held in an escrow account in the name of William A. Sibley, Jr., by United Community Bank ("UCB") Escrow Agent, account number 2405105749 (the "Escrow Account").

At the conclusion of the evidence presented by Defendant Decide4action, Inc. ("Decide4action"), the Court granted directed verdict in favor of Plaintiff against Decide4action

on (1) Plaintiff's cause of action for breach of contract, and (2) all of Decide4action's counterclaims and third-party complaint, and in favor Decide4action on Plaintiff's cause of action for breach of contract accompanied by a fraudulent act, all of which is the subject of a separate order dated July 28, 2021, and filed July 30, 2021.

The Court also finds and concludes that Decide4action has no "Pending Claims Amount" as set forth in the Indemnity Escrow Agreement dated October 16, 2017, among UCB, Decide4action, William A.L. Sibley, Jr., and the Sellers listed therein, Plaintiff's Exhibit 9 (the "Escrow Agreement").

Accordingly, pursuant to Section § 3(d) of the Escrow Agreement, UCB is directed to release and deliver all funds in the Escrow Account to Plaintiff Julia Sibley-Jones, as Personal Representative of the Estate of William A.L. Sibley, Jr.
