

The Appellant hereby moves pursuant to S. C. Ann. §18-1-100 (1962) and South Carolina Rules of Appellate Procedure, Rule 263(b), 240 for an extension of time in which to cure the Deficiency referred to in the Court's letter dated 8/2/2021 regarding my Supplemental Record. Good cause exists for this motion, as in the late evening on 8/9/2021, I discovered that I have been a victim of Bank fraud and I contacted my Bank. After finishing my research on 8/11/2021, I obtained a new contractor authorization for direct deposit from the company I contract with and just before online banking closed I was able to open a new account. This had to be done, so that my paycheck which was being on 8/12/21 (today) would not be affected. In this event I lost the last 3 days that I needed to finish the corrections for my Supplemental Record, which is due today. 


