truth. I am Quarantine with 4 other infected
inmates. My movement is severely restricted / as well
as me being restricted from staff.

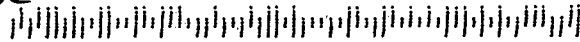

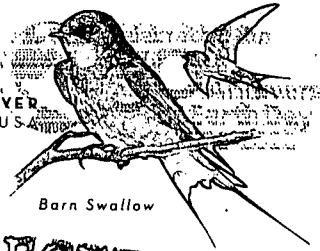
