MOTION TO AMEND THE DESIGNATION OF MATTER TO BE INCLUDED  
IN RECORD ON APPEAL AND FILE A SUPPLEMENTAL RECORD ON APPEAL

Pursuant to Rule 240 of the South Carolina Appellate Court Rules, counsel moves to amend the designation of matter filed with the initial brief of Appellant on January 4, 2021, to include the notice of intent to appeal and State's Exhibit #145. Counsel additionally moves to file a supplemental record on appeal to include the items in the amended designation.

1. 
