**THIRD STATUS REPORT**

---

On May 20, 2021, the Appellant Court granted the appellant’s Motion for the Time for Filing Amended Record on Appeal and Supplemental Designation of Matter be held in abeyance for 90 days pending the receipt of the requested transcript. Since the motion was granted, the appellant has reached out to the Court Reporter Manager multiple times: once on May 21, 2021, again on June 17, 2021, on July 7, 2021, on July 12, 2021, on July 22, 2021, and again on August 18, 2021. As of the date of this filing, the court reporter at the original hearing has not provided the transcript to the manager, nor have we received a copy as requested. The manager indicated that legal action has been taken on their behalf to try and procure the transcript from the court reporter. Since the appellant was granted 90 days in abeyance by the Court (Order, May 20, 2021), this filing would mark the final status update to be provided regarding the issue.

Additionally, Respondent Ruby Tuesday filed a Suggestion of Bankruptcy with this Court on July 23, 2021, to which the Court then ordered the appeal be held in abeyance for another 60 days (Order, July 27, 2021). Out of an abundance of caution, and to fulfill the order of the Court, the Appellant files this final status update and further requests that the Court inform the Appellant should any further action be taken to preserve the time to file our Supplemental Record on Appeal to include the transcript which has not yet been received.


